Billy- Recovery First Meeting. Allentown, PA meetings going well.

Chris carrying the message Group. Delaware. Baby blue meeting. 13 Homegroup members. Area is accepting us. They don't mess with us. Still on the meeting list.

Ken- Carrying message for Never Alone Never Again, Again Group.

Ray- Historical Perspectives Group. Allentown, PA We do a lot of printing. We put in two motions this year. *Complete Abstinence IP. Were not doctors IP*. Out for approval.

Kevin- Words Mean Nothing Group. Youngstown, OH Grey Book read through. Closed meeting. Active in H+I. Youngstown Prison. Hand out basic text. Grey Book, Baby Blue, IPs, own key tags. Group is doing well. Not too much grief from Area.

Hermen- Netherlands 5 times a week. 3 Homegroup members. Attendance, 1 to 7 people. Mostly 2 or 3. We go to the Hengelo Home Group. We do public information. Pamphlets and flyers. We have a phone number. Involved in the European Fellowship Conference. Most newcomers have been told not to come to our Homegroup.

Tom- Represent two meetings. The Original Grey Book Group. Consist of two people. Hard to keep the meeting open with two people. Struggling with wanting to close it down or not.

Tom- Unity Group. A lot of young members that don't know what Group conscience means. That is why we are not bringing a conscience. We meet Tuesday and Friday. We are involved in translation. We do printing. We have 13 members. We started new meeting on Friday we do the Grey book. We have started translating the Grey Book. We had 37 people last meeting. We do show up at area. We are not involved we go so they can talk to us if you like. We are putting aside money each month to print translated 3rd edition revised.

Belgium Sint Truiden Homegroup. Has meetings and are on the Nahelp meeting list. 5 people every meeting. 3 Homegroup meetings. They use free literature. They aren't on the areas meeting list. They do PI and H+I. They need support and the need experience. We try to support but meeting time is at the same as unity Group.

Kent- Honest Desire Willingness to Try Group. We meet every Monday. No matter what. We pay rent and we are not affiliated. We meet in their kitchen. 6 active members. Meeting attendance up to 10. Members use the Grey Book. Participants like the book. We give them away for free. Have given away a box of Grey Books. We do a line by line. Alive and well.

Erik. Group Report Hengelo, the Netherlands.

We have 4 meetings a week, 2 GreyBook studies and 2 BasicText studies. We also study Traditions once a week. Our Home Group consist of 12 members. Our Group registered at ASIS and is totally NAWS free. We use and give out Traditional literature.

PI is in infant-stage, we printed flyers, business cards, we have phone line and webpage that is run by members from multiple Groups in the Netherlands (NAhelp.nl). We have a member who translates weekly a part of the GreyBook.

Our Group (and likeminded groups) got a lot of heat and negative attention from NAWS structure and we are labelled Non-NA. This because our stance on Total Abstinence as described in the Basic Text and because we use/print/distribute Traditional NA literature and don't participate in Area/Region. Area/Region has an active approach on telling members and outside organizations (like treatment industry) to not visit our meetings yet the addicts that visit our Groups/meetings are in general very excited about our message and our atmosphere of recovery. Our Group (and likeminded Groups) took a beating, but we stand firm. We have steady attendance at our meetings, we get around average 6to8 members at our monthly Group Conscience/Business Meetings. We are financially healthy. At our meetings we share a pure & clean NA Message of Total Abstinence.

There are a bunch of committees and workgroups that spun off from our Homegroup. Projects like; the EFSC weekends (this year will be our 4th annual event), translations-day for the Baby Blue, we support (and produce) a lot of recovery literature and send these out worldwide at cost price and donated lots of literature to addicts & Groups worldwide. All funds are used to carry the message.

Members from our Group are also highly involved in the NA Way newsletter, writings of different pieces of literature and the writing/formatting/re-styling Traditional literature, and we have participated in the different Podcasts from Swan/RadioFree NA.

Alan- A Different Look Group. Philly. We study Grey book. One page a meeting. We also use paths of recovery book. We don't participate in area. We are on WSC meeting list app. 3 Homegroup members. 8-10 in attendance. We get people from word of mouth and from the app. Submitting two motions this year from IPs we wrote. (passed copies around) Members come there for a safe place to share.

Robert. Spiritual Solutions. NY 7 Homegroup members. 10-12 in attendance. Study Grey book. Approval draft. 2nd edition. 1985 IWH+Y. Fully self-supporting including insurance. Area does not bother us. We are on the WSC app as well.

85% of newcomers come from the app. We hand out free lit. We print lit. We use dog tags.

Report for ASIS group meeting in PA.

Columbus Nebraska Hope group along with the Grateful Wake Up group of Norfolk Nebraska has really enjoyed giving our Literature freely for many years. The Hope group has joined the ASIS as a rabbit meeting to accommodate our members.

We have giving free Literature to Nebraska Prisons and Jails. Also area treatment center, Jails in Iowa and Colorado with nothing; and even in motel rooms, Public libraries and on the streets.

We have attempted get along with all NA members. Nevertheless recently it was voted & passed by region in our State to take meetings off the region list of what is considered illicit literature groups. Also they have members taking to jails about throwing free unapproved NA lit away, targeting baby blues.

Our group feels it would be irresponsible not to attempt to convey in a positive way that to do any of these things could kill addicts. We have made much progress here to now start a war. It is incredible that for now there is disunity instead of harmony with what is working and we will have to get ahead of this. It would also be irresponsible not to brain storm on this. As what we have been doing on trying to get along has not had any positive response. To ignore this could lead to more members going underground or back out as it is very demeaning for those that enjoy the right to print and give away.

The Nebraska region member's feel a part of by being the trend setters for NAWS and do not care anymore about traditions or the chance their actions will end up killing someone. We have provided the H&I Nebraska region notes listed below

for examination. Also our group approved letter we will now be handing out with our free literature, for your examination. This also allows the institutions to let us know when they run out of lit.

With much discussion the hope group's conclusion is we would suggest we also have a short legal paper that we can present when a situation arises with the facts; We can print Literature legally as long as we give it away. We try and protect our home group members, however it has become a witch hunt here in Nebraska, where naw's politics is winning over those members that desire have any chance of being a speaker in Nebraska and not be black balled by the majority of the Nebraska fellowship. We are going to attempt to be more visible, letting members know we are not doing anything wrong and not violating traditions. Hiding under ones bed is not in any way the way Jimmy K. would of wanted it. We relize there is many that can realte to this report from the ASIS group, nevertheless it is frustrating to not go on the offensive more? What would happen in the USA if all Prison inmates were allotted a basic text? Anything would be better then what has been going on in the last 20 years in NAW's policy supported areas. We appreciate your permission in allowing our Narcotics Anonymous basic text into your institution; allowing us to give back freely what was given to us. I worked in corrections for 18 years and NA recovery is the only thing that worked for me and gave me a life worth living; free from the grip of the disease of addiction. This thin text takes little space and is hard to be utilized to hide contraband. It is approved by many jails and prison to be given to inmates all **over** the world. We have it made with or without staples for institutional preference. We hope you will allow the inmates to take their text home or leave it for another inmate. If you run out or have any questions please contact us.

From: Columbus Nebraska's Regions H&I report where they are going to take our Literature away from suffering addicts:

"Hey family. The Subcommittee meeting went well. Fremont Area's H&I is going well and continuing to grow! Great Plains is doing well and diligently working towards minimizing unapproved literature. SENANA is doing great! They will be having an H&I training day on June 15th, 2019 at City Impact. Central is also doing great! They recently got a good group of individuals H&I trained. I will begin purchasing Introductory Guides instead of soft cover Basic Texts for a while. There was a further discussion during the subcommittee meeting about how we can handle unapproved literature when it comes to H&I. It was a mentioned that it is H&I members responsibility to have appropriate discussions with facilities, remove said literature when noticed, and in general not to support groups to continue pushing unapproved literature. All in all things are going well and continuing to move forward. On another note, there was a PI meeting of sorts that included important members from correctional facilities. I was not able to make it to this meeting. However, I hear that a lot of amazing things come from this meeting that will greatly affect H&I members being able to go into prisons through a more streamlined process. I was not getting emails regarding this, as they were accidentally being sent to an invalid email address, however, I am planning to look further into all of this and will bring more information as I figure it out! Gratefully In Service, Tera N. Note: In attendance for the subcommittee meeting: Fremont, EVANA, Great Plains, Central, & SENANA. Areas that were absent: Platte Valley, ENNA, Southeast Survivors."

Fact borrowed from member -

Here's the deal... the UK trusted (sic) servants at the regional level engage, as does the WB and WSO, in 'gaslighting' the entire fellowship. To those not familiar with the concept... 1. they withhold information from the fellowship, 2. give counter (false) information to fit their prospective, 3. they discount any information that does not fit their 'story', 4. undermine those that question

practices and trivialize claims of questionable practices, 5. change the conversation placing themselves as victims... They have been doing this since the early 80's. They do it consistently never deviating from their 'script'. And it works very well for them. Why? Perhaps because most addicts see themselves as 'victims' and sympathize. But until you change this dynamic, change will never come..

Gwen- The Old School Traditionalist Group. Camden, SC. We do Grey Book and Group in the area now gives out baby blues. They also want to use dog tags. Our Group has a 40% newcomer rate.

Finally Free Group in Sweden. (See pictures)

Group report "Finally free" group Sweden

We recently celebrated our two-year anniversary for our Homegroup and meeting. Since we started, we have been working hard to get a lot of the literature translated in to Swedish, not just the book, to make our meetings as available as possible to addicts in Sweden. We are currently going through our book again to fix the small errors and such we have found. This has not always been easy, right from the start our group was made out to be something bad and "Illegal". This has resulted in us not having any support from other addicts in the area, but rather they worked against us and told addicts not to come to us. This is still an issue and we still have to face that not all addicts even are willing to try our meetings. Luckily since we started to focus on our message instead of what other groups say about us, more and more people has started to come. So far most of the addicts that come to us feel welcomed and as a part of the group as soon as they walk in the door. The area recently realized that we are not doing anything illegal and as such they will have to learn to live with us. So, in focusing on our message and our traditions we have overcome the problem of addicts not coming to us. Although, we have also seen a rise in visitors from the other structure and more addicts seem to be willing to give us a chance. All we want is to carry the message to the addict that still suffers. We usually have between 4 to 10 addicts attending our meetings. We are currently having 4 meetings per week, two in Delsbo and two in Hudiksvall. Monday's Steps and Traditions meeting (Hudiksvall), Wednesday's Literature Topic meeting (Hudiksvall), Thursday's Literature Topic meeting (Delsbo) and Sunday's Literature Study meeting (Delsbo). Once a month we have a speaker on Skype, we have had 5 so far and all are available on our website. We have had our website since january, www.nahelp.se. Our hopes is that this will reach more suffering addicts in Sweden.

Like with most groups we have had to face not only outside issues, but also inside issues. As we were growing, we started to have some problems in the group with personalities going before the principles. There was conflicts in the group on how to work forward and fear crept into our Group. Unfortunately we lost a couple of members in this process, but the ones who decided to stay grew stronger and we learned a lot from this period of time. The importance of not focusing on what people were saying behind our backs, to not read the area reports from the other structure, to keep an even more vigilant eye to our Traditions, to have group inventories, to stay connected with other members and groups who's a part of A.S.I.S for NA and to keep our focus on our primary purpose.

Six months ago we have had issues with some of the members feeling like a few does a lot and that this makes them feel like the are not a part of the group. With this

the group had to do an inventory to locate the issue. With this we could see that we need to be better at inviting to different services and making it more available by doing it on different days and times to make everyone feel like they have a choice to get involved. We have discussed the issue in the group and a lot has already been won just by talking honestly with each other, not about one another. This is no longer considered an issue but it did help us grow as a group.

In our PI/H&I efforts we started by putting up posters in the areas around our meetings. Right now we are about to check our posters and put up new ones if needed. We also sent emails, with information on who we are, what we do and that we would like to meet them, to different institutions in the area. The result was that we have had three H&I meetings, two different treatment centers and at social services. Two of our members went to the first treatment center were they informed about NA and shared some of their experience, strength and hope. We left about ten Basic Texts and about 20 IP's. At the second treatment center we had two members go and inform what NA is and from that we have now been invited back every 10 weeks to talk to their treatment groups. In this we also gained a new Home Group member. We had three members go to social services were they informed the personnel working there what we are and why we exist. We also put together an IP containing different parts from our literature to inform addicts how to find us and our contact information.

Our group has seen that there is a need to be connected with other groups and members to solve the issues and get help in our growth, as with etc. Pl., H&I., literature and how to carry the message and fulfil our primary purpose. We have had members going to the last two EFSC and we have 7 members committed to go this year.

We want to ask about more ESH about PI/H&I, right now we just do "maintenance" work like checking if the flyers are still up, sending some more emails and such. But we would love some ideas on what more to do in this area?

We would also love to hear some more ESH about total abstinence within others Homegroups and how you deal with people sharing, serving on "medication"? Do you ask the person if he/she is on any mood changing and mind altering substances before they taking on any service position?

Group Report 'Original NA Enschede'

Last year was rough as we had a big split in our Group. This was fueled by personal-opinions, ego, lack of understanding Traditions and NA History, and a different view on Total Abstinence as described in our BasicT ext.

Long story short; after many discussions, politics, drama and personal attacks, a new (Naws orientated-Group) was created, yet the original Group kept true to the Conscience and now has 4 Homegroup members, is financially healthy, sit once a week on Wednesday (the Friday is currently on hold) and study's the IWH&W blue form (one of the members always translates the part we study), supports free literature, joined ASIS/totally Naws free, and carry's an undiluted message of NA. We get on average around 8 people and are growing. Also, members from the group that wanted to split, come visit our meeting on regular basis. Our PI is in infant stage, we have our own phone line and website; addicts find us.

The Home Group members are (also see Hengelo Group Report) highly committed to service in different committees/workgroups; translations, writing, printing/distribution of Traditional NA literature, the EFSC, creating of website NAhelp.nl, etc.





Report from Erik on the Book Order (What was said on the Conference floor in addition to the Report from the Historical Perspective Group.)

I have been in contact with printers in Europe for two years and help setting up orders for the Netherlands and also for the Historical Perspective Group. The problem we ran into this last order is that we couldn't match the same quantities as the previous order. This is described in the report of the Historical Perspective Group. The main issue is the shipping price. It's based on weight of the total

shipment and we found out that when the order/weight gets less, the price per book will go up pretty substantial. The risk is that when we can't get the same quantities every time, it is impossible to get a decent and set price. This way it becomes a risk when Groups have already put in money and have to wait a long time for the target number of books being reached. The second risk is when the price goes up and there is a gap between collected money and the invoice that has to be paid.
